3. Supervising the Board of Management by the Board of Directors:

Pursuant to the Charter and Internal Regulations on corporate governance, the Board of Directors has carried out inspection and supervision of the Board of Management in managing and operating HHV's production and business activities and implementing the Resolutions of the General Meeting of Shareholders and the Board of Directors in the first 6 months of 2025, as follows:

3.1. Supervising method:

- Assign members of the Board of Directors to be in charge of, supervise and directly inspect each important field of production and business activities of HHV; at the same time, promote decentralization to members of the Board of Directors to be represented by the Board of Directors to provide orientation, direction and feedback so that the Board of Directors can adjust the operation plan promptly and appropriately.
- Organize regular (monthly, quarterly and semi-annual) and unscheduled inspection for the Board of Management to report on the results of implementing production and business plans; evaluate the Company's operations in each period; orient key tasks for the next period and propose solutions to promptly remove difficulties and obstacles (if any) to support the Board of Management to achieve results and efficiency according to the set plan.
- Require the Board of Management to strictly implement the monthly (and unscheduled) reporting regime on the Company's operations with specific and complete reporting content according to the management motto "Three managements: Manage people Manage work Manage benefits". After each reporting period, the Board of Directors has inspected, evaluated and provided timely and accurate instructions and directions for the Board of Management to implement.

- Closely inspect and supervise financial and accounting work as well as the preparation, issuance and audit of Financial Statements, Annual Reports and other important reports of the Company arising during the period.
- Monitor and supervise the activities of the Board of Management through sub-committees under the Board of Management, namely the Internal Audit Committee and the Internal Control Committee. The members of Board of Management in charge of the subcommittees have oriented the contents and issues that need to be focused on monitoring, inspecting and controlling so that the subcommittees can specify them in the control and auditing plans, contributing to improving the effectiveness of the monitoring activities for Board of Management.

3.2. Supervising results:

3. Supervising Board of Directors, Board of Management and shareholders by Board of Supervisors

3.1. Based on the duties and powers according to the Charter and Internal Regulations on corporate governance, the Board of Supervisors has implemented supervision activities for the Board of Directors and the Board of Management in the first 6 months of 2025, specifically as follows:

- Assign a Supervisor (KSV) to monitor and supervise compliance and appropriateness in the organization order of the 2025 Annual General Meeting of Shareholders, meetings and procedures for issuing Resolutions/Decisions of the Board of Directors as well as the implementation of Resolutions of the General Meeting of Shareholders and the Board of Directors. At the same time, participated in reviewing and giving opinions on reports and submissions of the Board of Directors and the Board of Management at the annual General Meeting of Shareholders.
- Supervise and evaluate the legality and reasonableness of the actions in performing the duties and powers of the members of Board of Directors, the General Director and members of the Board of Management in implementing the production and business plans and the Resolutions of the General Meeting of Shareholders and the Board of Directors according to regulations. The Supervisors directly worked and discussed with the General Director and members of the Board of Management on the contents and issues in the Company's operations that the Board of Supervisors was interested in.
- Check and assess the legality, accuracy and honesty of financial reports, production and business results reports and other important reports of the Company to submit to the General Meeting of Shareholders for consideration and approval. At the same time, the Board of Supervisors submitted to the General Meeting of Shareholders for approval of the list of independent auditing companies in 2025 as well as regularly monitored and evaluated the independence and objectivity of the independent auditing unit for the Company's financial statements and other reports.
- Supervise and evaluate the effectiveness and compliance level of the Company's internal audit system, internal control and risk management and early warning mechanisms.
- Regularly update and review the list of major shareholders, related parties and internal persons of HHV to monitor, supervise and give comments on the approval procedures and implementation of contracts and transactions between the Company and related parties.
- 3.2. The Board of Directors and the Board of Management have created favorable conditions for the Board of Supervisors to supervise and implement other activities within the scope of assigned functions and tasks. Through monitoring, the Board of Supervisors found: The Board of Directors has performed the administration and management of the Company in accordance with its authority and duties as prescribed by law, in accordance with the Charter and Resolutions of the General Meeting of Shareholders; the CEO and members of the Board of Directors have complied with their assigned functions and duties, proactively implementing plans according to the Resolutions of the General Meeting of Shareholders and the Board of Directors. In addition, in the first 6 months of 2025, the Board of Supervisors has not received any feedback from Shareholders on violations by the Board of Directors and the Board of Management in the performance of assigned duties and powers; at the same time, the Board of Supervisors has regularly updated Shareholders' opinions to request the Board of Directors and the Board of Management to receive feedback to ensure the legitimate rights and interests of Shareholders.
- 4. The coordination among the Board of Supervisors, the Board of Management, Board of Directors and other managers:

- 4.1. The Board of Directors, the Board of Supervisor, other management levels of the Company and the Board of Supervisors have regularly coordinated in activities through various forms of exchange and provision of complete and timely information. The Board of Supervisors proactively implemented the monitoring plan after informing the Board of Directors, the Board of Supervisor and the units about the monitoring content and time; at the same time, the Board of Supervisors was flexible so as not to affect the normal operations of the department during the inspection and monitoring process.
